Who's Lobbying Who in BC?

Monthly Snapshot - June 30, 2013

The following organizations and consultant lobbyists submitted their registrations under the BC Lobbyists Registration Act between June 1 and June 30, 2013. - 31. The Canadian Bankers Association is lobbying a number of public office holders on a wide range of issues including modification of the *Securities Act* and encouraging the development of financial abuse prevention policy.
- 32. The Canadian Generic Pharmaceutical Association is lobbying the Minister of Health and ministry staff on several issues including reimbursement of pharmacists for dispensing generic drugs and the prices of generic drugs.
- 33. Canadian Pacific is lobbying a number of public office holders on a range of issues including validation of CP's approach to land based spill response and development of an infrastructure for and promotion of the Pacific Gateway.
- 34. Canadian Tire Corporation, Limited is lobbying several ministers (and/or their staff) regarding negotiated debt relief and partnership opportunities to help encourage youth participation in sport and physical activity.
- 35. The Construction Labour Relations Association is lobbying several MLAs and Public Agencies on a range of topics including apprenticeship reform and training tax credit revisions.
- 36. The Downtown Vancouver Business Improvement Association is lobbying the Office of the Premier, the Minister of Transportation and Infrastructure and ministry staff to seek repeal of the parking right tax and to advocate for it to be replaced with a transportation improvement levy or road tolls.
- 37. FPInnovations is lobbying several ministers for financing of forestry and forest products related research projects for the support of the British Columbia resource sector.
- 38. General Motors of Canada Limited is lobbying the Office of the Premier and several ministers on a number of topics including adoption of advanced technology vehicles in accordance with BC's GHG reduction goals.

- 39. The Health Sciences Association of BC is lobbying several ministers and MLAs on a number of issues including promoting the training, recruitment and retention of health science professionals.
- 40. Imperial Oil Limited is lobbying several public office holders on a number of topics including encouragement of the adoption of pro-development fiscal policies for natural gas in BC.
- 41. The Investment Industry Association of Canada is lobbying the Office of the Premier and the Minister of Finance to encourage addressing issues important to the investment industry and the development of a national securities regulator.
- 42. The Mining Association of British Columbia is lobbying a number of public office holders on a number of issues including improvements to the mine permitting process and trades training.
- 43. Pfizer Canada is lobbying several public office holders on a number of issues including seeking new partnerships in science and technology.
