Who's Lobbying Who in BC? Monthly Snapshot - May 1 to May 31, 2012

The following organizations and consultant lobbyists submitted their registrations under the BC Lobbyists Registration Act between May 1 and May 31, 2012. The full details of each registration are searchable at www.lobbyistsregistrar.bc.ca.

- Brian Canestraro, an in-house lobbyist for Gilead Sciences Canada, Inc., is arranging meetings with Ministry of Health staff to provide briefings about their company, existing products and value offerings as well as to negotiate with BC PharmaCare.
- 2. Bruce Carter and Matthew Angus, in-house lobbyists for the Greater Victoria Chamber of Commerce, are lobbying several public office holders on a broad range of topics including a housing first policy as part of social programming, changes in financial reporting, and the airport expansion.
- 3. Josh Christensen, a consultant lobbyist with Hill+Knowlton Strategies, is arranging meetings with MLAs Ida Chong (Oak Bay-Gordon Head) and Maurine Karagianis (Esquimalt-Royal Roads) on behalf of his client, Amgen Canada Inc., to discuss an education award.

- 5. Josh Christensen is arranging meetings with MLAs Adrian Dix (Vancouver-Kingsway) and Carole James (Victoria-Beacon Hill) on behalf of Enbridge to provide information about the company and the proposed Northern Gateway Pipeline project.

In-house lobbyists for The Nature Conservancy are lobbying the Minister of Forests, Lands and Natural Resource Operations and the Intergovernmental Relations Secretariat to encourage ownership of timber tenures, limiting mining and oil and gas activities in the Flathead River basin and limiting trophy hunting on the B.C. coast.
- 24. In-house lobbyists for TransAlta Corporation are proposing potential electricity generation solutions to government to meet the rising demand in BC.
- 25. In-house lobbyists for the TransCanada Corporation are lobbying numerous public office holders on construction of the new pipeline infrastructure including NOVA Gas Transmission Ltd., Foothills Pipe Lines Ltd., and the Alaska Pipeline.
