Who's Lobbying Who in BC?

Monthly Snapshot – March 2019

The following organizations and consultant lobbyists submitted their registrations under the B.C. Lobbyists Registration Act and they were activated between March 1 and March 31, 2019. Here is a brief summary of lobbying activities organizations and consultant lobbyists have or expect to carry out. The BC Care Providers Association is lobbying several public office holders on a number of issues including supporting extended post-graduate work permit eligibility to private career colleges, requesting funding for the purpose of a Safety Training and Equipment Program, and making recommendations about the independence of the Office of the Seniors Advocate.
- 35. The BC Dental Association is lobbying staff of the Ministry of Social Development and Poverty Reduction to discuss key concerns regarding the ministry's dental coverage.
- 36. The British Columbia Wine Institute is lobbying a number of ministers regarding continued support of key Provincial policies, including Direct-to-Consumer Delivery, BC wine and food tourism, and BC Wine Authority recommended legislation changes.
- 37. Brookfield Energy Marketing Inc. is lobbying several public office holders to seek the issuance of permits or other approvals or exemptions for new and existing energy projects, to encourage the awarding of Energy Purchase Agreements, and to encourage the development of energy policy that facilitates renewal, development and expansion of opportunities for independent power producers.
- 38. The Canadian Association of Petroleum Producers is lobbying a number of public office holders on a range of issues including promoting electrification of the upstream natural gas industry, market access

- for natural oil and gas, and upstream competitiveness in comparison to other jurisdictions and the meaning of Energy Intensive Trade Exposed industries.
- 39. The Canadian Federation of Independent Business is lobbying a number of public office holders on a broad range of issues including red tape reduction, budget issues, labour issues, municipal issues, liquor regulations and utilities.
- 40. Canadian Fuels Association is lobbying several ministers on renewable fuels and low carbon fuels regulation requirements, contaminated sites standards and policies, fuel tax regulations, and the Transportation of Dangerous Goods policy directive.
- 41. Canadian Pacific is lobbying a number of public office holders to provide the Canadian Pacific perspective on Federal transportation policy relevant to BC, and to provide information on Canadian Pacific emergency planning and response.
- 42. Canfor Corporation is lobbying several public office holders on a range of issues including the softwood lumber dispute, operational issues affecting BC's interior forest industry, and engagement with industry around land use decision making.
- 43. Central 1 Credit Union is lobbying the Minister of Finance (and her staff) and staff of the Financial Institutions Commission to ensure the lending capacity of credit unions and to ensure a fair and balanced legislative and regulatory regime for the BC credit union system in the future.
- 44. The Commercial Bear Viewing Association is lobbying a number of public office holders to inform and build bear viewing in British Columbia.
- 45. ConocoPhillips Canada Resources Corp. is lobbying a number of public office holders to influence the implementation details of the CleanBC Program, to work closely with first nations communities and the BC government through RSEA, and to engage on legislation and policy related to the energy industry.
- 46. The Downtown Vancouver Business Improvement Association is lobbying a number of public office holders to effect changes to the Vancouver Charter regarding the Business Improvement Area renewal process and to discuss issues around property crime offenders.
- 47. D-Wave Systems Inc. is lobbying several public office holders to establish a quantum computing application ecosystem in BC.
- 48. The Electrical Contractors Association of British Columbia is lobbying a number of public office holders regarding Prompt Payment legislation, and to ensure there are enough trained journeyperson electricians in the province to do the work required to reduce our climate footprint.

- 49. Finning International Inc. is lobbying the Minister of Jobs, Trade and Technology to discuss the economic contribution of Finning International Inc. to the BC economy.
- 50. First Call: BC Child and Youth Advocacy Coalition is lobbying a number of public office holders on several issues including developing quality, affordable, accessible child care, and reducing and eliminating child and family poverty.
- 51. FortisBC Inc. is lobbying several public office holders relating to the possible sale or lease of FortisBC real property, and the development of policies and funding to expand electric vehicle charging infrastructure.
- 52. Gateway Casinos & Entertainment Limited is lobbying a number of public office holders on current property developments, future development plans and economic contributions to the various municipalities and the province, and updates and discussions on the German Report.
- 53. HeliCat Canada Association is lobbying a number of public office holders concerning occupational health and safety policies and programs, BC Parks, Wildlife and related policies and programs, and land management and adventure tourism policies and programs.
- 54. The International Union of Operating Engineers Local 115 is lobbying a number of public office holders regarding labour law, labour code, legislation and Community Benefit Agreements.
- 55. Janssen Inc. is lobbying several public office holders to discuss public reimbursement policies and procedures related to innovative pharmaceutical treatments and co-diagnostics, and to explore research and innovative partnership opportunities.
- 56. Lafarge Canada Inc. is lobbying several public office holders regarding the deployment and execution of low carbon fuel incentive program and utilization and adoption of low carbon cement in government infrastructure.
- 57. Languages Canada is lobbying the Minister of Advanced Education, Skills and Training (and her staff) regarding review of Private Training Act with respect to regulation of private language schools.
- 58. The Multiple Sclerosis Society of Canada, BC and Yukon Division is lobbying several public office holders to advocate for improvements to home and community care for people living with multiple sclerosis, advocating for BC disability legislation, timely access to approved MS therapies, and improved disability benefits for people living with MS.
- 59. Navigata Communications Limited is lobbying staff of the Ministry of Citizens' Services regarding the provision of terrestrial and wireless telecom circuits and services throughout the Province.

TransCanada Corporation is lobbying a number of public office holders on several topics including government support for Coastal GasLink Pipeline, NOVA Gas Transmission Ltd. and Prince Rupert Gas Transmission Project and the construction and long-term operation of one or more gas pipelines to Kitimat and/or Prince Rupert from the northeast gas producing regions.
