## BC?

## **Monthly Snapshot – March 2020**

The following organizations and consultant lobbyists submitted their registrations under the B.C. Lobbyists Registration Act and they were activated between March 1 and March 31, 2020. Here is a brief summary of lobbying activities organizations and consultant lobbyists have carried out or expect to carry out. - Michael Bailey, a consultant lobbyist with Western Policy Consultants Inc., is lobbying staff
  members in the Ministry of Municipal Affairs and Housing on behalf of the BC Camps Association
  regarding proposed changes to the Amusement Rides and Devices Regulation.
- 2. Nicole Brassard, Kimberly Haakstad and Matthew Williamson, consultant lobbyists with Global Public Affairs, are arranging meetings with a number of public office holders on behalf of Restaurant Brands International Inc. regarding issues related to the franchise industry, the impact of COVID-19 on the restaurant industry and measures the government is taking to mitigate this impact.

Gurpreet Vinning, a consultant lobbyist with Prospectus Associates, is lobbying the Minister of Jobs, Economic Development and Competitiveness on behalf of the BC Tech Association regarding the ScaleUP BC Tech programs and exploring avenues for joint funding between the BC Government and Federal Government.
- 31. Gurpreet Vinning, a consultant lobbyist with Prospectus Associates, is lobbying staff members in the Office of the Premier on behalf of Wine Growers Canada/Vignerons Canada, regarding an anticipated ruling from the World Trade Organization challenge of Canadian Wine Measures with respect to the federal excise tax, and potential measures and impacts related to the ruling.
- 32. Ian Waddell, a consultant lobbyist, is arranging a meeting with the Minister of Public Safety and Solicitor General and compliance officers on behalf of his client, Sunny Bhayana, regarding regulation of cannabis.
- 33. Bruce Young, a consultant lobbyist with Earnscliffe Strategy Group, is arranging meetings with a number of public office holders on behalf of WuhanEasy Diagnosis Biomedicine Co. Ltd. regarding the company's various test kits for COVID-19 that have been deployed in other jurisdictions.

- 34. AltaGas Ltd. is lobbying a number of public office holders on a range of issues including: property tax treatment of AltaGas assets in BC, development of a favourable policy framework for energy exports to foreign markets, development of a framework for the timely exchange of information between Indigenous Peoples and companies with energy projects.
- 35. The Advanced Biofuels Canada Association is lobbying several ministers regarding transportation energy policies and programs, including the Renewable and Low Carbon Fuel Requirements Regulation (RLCFRR), carbon tax and other policies, statutes, regulations and standards to support production and use of advanced biofuels in BC.
- 36. The Adventure Tourism Coalition of BC is lobbying several public office holders to advocate for changes to government policies and legislation to improve business certainty and stability for the adventure tourism industry.
- 37. Amazon Canada Fulfillment Services, Inc. is lobbying several public office holders to promote and facilitate BC's digital sector, and to ensure the availability of a high-skilled tech workforce.
- 38. BC Building Trades is arranging meetings with a number of public office holders to discuss a variety of matters including opportunities for local hire, apprenticeship and access for underrepresented groups to trades training; strengthening government action against the underground economy; and changes to the Labour Relations Code, Employment Standards and Workers' Compensation/WorkSafe BC.
- 39. The BC Care Providers Association is lobbying several public office holders on a number of issues including funding and policy changes to address human resource challenges in BC's continuing care sector; funding of a Safety Training and Equipment Program for front line employees in BC's continuing care sector; recommendations regarding the independence of the Office of the Seniors Advocate; support for new long-term care and assisted living spaces; expansion of education and training opportunities for community health workers, health care aides and licensed practical nurses; and processes to be put in place to support seniors living and continuing care operators during the COVID-19 Pandemic.
- 40. The BC Federation of Students is lobbying a number of MLAs regarding a variety of matters including: creation of a need-based grant program in BC by re-investing existing completion grants; regulation of international student fees and the creation of an international student strategy; and review of sexual misconduct policies on campus.
- 41. The British Columbia Wine Institute Society is lobbying the Minister of Agriculture and the Minister of Attorney General regarding Agricultural Land Commission Policy L-03 that limits the allowable

- development area on the particular parcel of Agricultural Land Reserve land upon which a winery is located.
- 42. Canada's Digital Technology Supercluster is lobbying a number of public office holders in the Ministry of Jobs, Economic Development and Competitiveness to expand digital technology innovation, research and development, and the development of talent, and to discuss the Supercluster's current program areas in Technology Leadership and Capacity Building.
- 43. The Canadian Consumer Speciality Products Association is lobbying the Premier, the Minister of Environment and Climate Change Strategy, and Ministry staff, regarding legislation related to pest control products, and end of life management of packaging and paper waste materials, solvents and flammable liquids, and pesticides.
- 44. The Canadian Fuels Association is lobbying a number of Ministers regarding a variety of matters including: renewable fuels and low carbon fuels requirements; carbon pricing mechanisms; the initiative for the BC Oil and Gas Commission to be a new single source regulator for BC refining; standards and policies regarding air and water contaminants and contaminated sites; BC spill regime standards and policies; Transportation of Dangerous Goods policy; and fuel tax regulations.
- 45. The Canadian Home Builders' Association of BC is lobbying a number of public office holders regarding the significant jobs and economic development within the residential construction industry, market housing affordability as part of the larger housing plan, and economic opportunities for the residential construction industry.
- 46. The Canadian Propane Association is arranging meetings with a number of public office holders to promote low-emission propane as a replacement fuel for carbon-intense fuels in various sectors, including transportation, fisheries, and agriculture, and to promote worker training in the handling of propane and related fields such as gas fitting.
- 47. Canopy Growth Corporation is arranging meetings with a number of public office holders to provide information on Canopy Growth Corporation's products and operations, and advocate for advancement of the cannabis retail framework and increasing opportunities for consumption sites.
- 48. The Commercial Bear Viewing Association is arranging meetings with a number of public office holders to discuss the bear viewing industry and the overall well-being of wildlife and their habitat.
- 49. Cystic Fibrosis Canada is lobbying a number of public office holders to improve access to cystic fibrosis medicines and quality CF care.
- 50. D-Wave Systems Inc. is arranging meetings with the Minister of Jobs, Economic Development and Competitiveness to seek government support for academic and industry collaborations to apply

- quantum computing research and development in diverse areas such as natural resources, healthcare, manufacturing and materials science. This support may be in the form of investments in university programs, funding for industry collaborations, advocacy with other levels of government, and assistance with international export.
- 51. The Federation of Post-Secondary Educators of BC is lobbying a number of public office holders on a variety of issues including comprehensive reforms to the post-secondary system (such as post-secondary funding, international education, developmental programs, the Industry Training Authority, tuition and fees), advocating for faculty to be fairly represented in post-secondary government structures and the need for adequate resources to decolonize and work towards reconciliation on our campuses.
- 52. Geoscience BC is arranging meetings with a number of public office holders to provide an overview of Geoscience BC's projects in an effort to encourage long-term, predictable funding for the organization.
- 53. Gilead Sciences Canada, Inc. is arranging meetings with a number of public office holders regarding the provincial listing and reimbursement for HIV and oncology medications, and medications for the treatment of viral hepatitis, liver disease and rheumatoid arthritis, as well as public health policy more generally.
- 54. The Greater Vancouver Board of Trade is lobbying several ministers regarding a variety of matters including investment in worker training and student housing in the Greater Vancouver region; implementation of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP); climate change solutions that work for business; programs to support mental health and addictions treatment in the Greater Vancouver region; affordable, available transportation options for workers and business; and tourism as a growth sector for the Greater Vancouver region and BC.
- 55. The Greater Victoria Chamber of Commerce is lobbying several ministers on a number of issues, including investment in worker training and student housing in the Greater Victoria region, investment in child care, investment in mental health and addictions treatment, fair taxation, development of climate change solutions that work for business, investment in greater public safety through policing and fair, transparent regulation of cannabis.
- 56. The HeliCat Canada Association is lobbying a number of public office holders regarding the following subject area policies and programs, as they relate to the helicopter and snowcat skiing

- sector in BC: occupational health & safety; BC Parks, wildlife and related matters; and land management and adventure tourism.
- 57. Imperial Oil Limited is lobbying a number of public office holders regarding several matters including the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP); adoption of pro-development policies for LNG in BC; repeal or amendment of renewable fuels policies; BC LCFS Refinery Improvement Credit; tax compliance planning; and advocacy relating to environmental policies, site remediation policy and compliance.
- 58. Innergex Renewable Energy Inc. is lobbying a number of public office holders regarding renewable energy, climate policy and other issues relevant to the renewable energy sector.
- 59. Janssen Inc. is lobbying a number of public office holders to discuss public reimbursement policies and programs related to innovative pharmaceutical treatments and co-diagnostics, and to explore research and partnership opportunities.
- 60. Lundbeck Canada Inc. is lobbying a number of public office holders with respect to policies respecting medicine reimbursement programs such as BC PharmaCare, as well as market access for Lundbeck's portfolio of medicines and listing of Lundbeck's products for reimbursement purposes.
- 61. The Michael Smith Foundation for Health Research is lobbying a number of public office holders to discuss core mandate and continued funding for the Province's health research sector.
- 62. Mosaic Forest Management is lobbying a number of public office holders regarding existing and proposed regulations, policies and reviews related to the BC coastal forest sector, including private managed forest regulations, taxes, property assessments, log exports, stumpage, coastal revitalization initiative, First Nations consultation and accommodation, and land use planning.
- 63. The Movement of United Professionals (MoveUP) is arranging meetings with an extensive list of public office holders to discuss issues related to public auto insurance (ICBC).
- 64. Novartis Pharmaceuticals Canada Inc. is lobbying several public office holders to discuss reimbursement of Novartis' pharmaceutical treatments by the BC government for citizens that require access to these treatments.
- 65. The Rick Hansen Foundation is lobbying a number of public office holders on a range of issues including the incorporation of accessibility policies vis-à-vis BC's comprehensive capital infrastructure plan in terms of all new construction, the well-being of the Pacific Fishery, and the importance of conservation and protection measures (e.g., quotas, catch and release for tagging

- purposes only or an outright ban on fishing) with respect to sturgeon in light of the dwindling population of sturgeon in BC.
- 66. Rio Tinto is lobbying a number of public office holders on a variety of issues including support for the Watershed Engagement Initiative; implementation of the *Declaration on the Rights of Indigenous Peoples Act*; opportunities to participate in the Clean Energy BC program; climate change policy, developing benchmarks for global greenhouse gas emitters and Ambient Air Quality Objectives; requesting provincial support for modification of federal tax policy treatment for mining sector; funding for the expansion of cellphone connectivity in north central BC; and regional economic development opportunities related to Nechako Reservoir.
- 67. Siemens Canada Limited is lobbying an extensive list of public agencies relating to the sales and marketing of their products and services in the fields of electrification, automation and digitalization, including electric vehicle infrastructure; extraction and transport of oil and gas; liquefied natural gas; power generation (including wind), transmission and distribution; manufacturing, transportation, building technologies, water technology and lighting industries.
- 68. The Surrey Board of Trade is lobbying a number of public office holders regarding a variety of matters including an assessment framework for a labour skills centre; the property tax structure related to agricultural land; arts education; higher levels of investment in childcare facilities; funding to implement disaster mitigation programs; the processes for phasing out plastics and Styrofoam; PST rebates on production inputs; housing policies and incentives; and ridesharing.
- 69. Western Stevedoring Company Ltd. is lobbying several ministers regarding the current review of the BC Ports Property Tax Act.
