

WHO'S LOBBYING WHO IN BC? Monthly Snapshot – July 2023

The following is a brief summary of new Registration Returns activated or re-activated between July 1 and July 31, 2023 under BC's *Lobbyists Transparency Act*.

British Columbia Nurses' Union is lobbying public office holders at several public agencies regarding a variety of matters such as staff recruitment and retention, changes to fee increases, legislation on PTSD coverage for nurses, workplace health and safety, access to pandemic supports and personal protective equipment, supports for mental health related issues, substance use disorders and addition-related illness, education seats in post secondary school system and the state of seniors' care.

- 28. Canadian Geothermal Energy Association (CanGEA) is lobbying public office holder at several public agencies regarding regulatory parity for the geothermal industry broadly and fiscal support for geothermal development in the Clean BC programs to encourage investment in this critical emerging industry.
- 29. Chegg Inc. is lobbying public office holders at several public agencies regarding online learning, workforce skills development and artificial intelligence.
- 30. Brightside Community Homes Foundation is lobbying public office holders at several public agencies regarding policy on barring fossil fuels for new multi-unit family homes construction.
- 31. Digital Identity Laboratory of Canada is lobbying public office holder at several public agencies regarding funding and to participate in projects, facilitated by the Laboratory, involving the issuance, verification, and interoperability of digital credentials.
- 32. Gold River Aquafarms Ltd. is lobbying public office holders at several public agencies regarding financial support to transition from in-ocean, open net fish farms.
- 33. First United Church Community Ministry Society is lobbying public office holders at British Columbia Housing Management Commission regarding changes to the *Residential Tenancy Act* to strengthen renters' rights and alleviate bad faith evictions and funding for the non-residential portion of the redevelopment project from the Ministry of Housing.
- 34. Fort St John & District Chamber of Commerce is lobbying public office holders at several public agencies regarding a variety of matters such as: taxation regimes, labour shortages, education, health, resource development, economic development, impacts of climate change, immigration, housing, transportation infrastructure, housing, mental health, public safety, cost of doing business in BC.
- 35. H.I.M. Health Initiative for Men is lobbying public office holders at several public agencies regarding availability of treatment options for injectable Human Immunodeficiency Virus and changes to policy regarding age brackets of persons eligible to receive the Human Papilloma Virus vaccination.
- 36. Interior Savings Credit Union is lobbying public office holders at several public agencies regarding matters related the soundness of credit unions and the safety of depositors, the Credit Union Deposit Insurance premiums and fund, the Financial Institutions Act and/or *The Credit Union Incorporation Act*, and the supervision of the Credit Union by the British Columbia Financial Services Authority (BCFSA).

- 37. Kelowna Community Resources Society is lobbying public office holders at several public agencies regarding contract negotiations, programs to meet community need and funding to fill gaps in service for those in need.
- 38. Lime Technology Inc. is lobbying public office holders at several public agencies regarding the *Motor Vehicle Act* Pilot Project as it pertains to electric scooters and proposals received from local communities.
- 39. LNG Canada Development is lobbying public office holders at several public agencies regarding a number of topics including BC Hydro North Coast Expression of Interest; changes to climate policy and regulations; Community-level Infrastructure and Services Management Plan (CLISMP) / Social Management Roundtable (SMR); changes and impacts to the environmental assessment process on existing certificates as well as future amendments/applications; fiscal impact of LNG Canada on BC economy; waste discharge authorization for operations; suggestions on Major Industry Property (MIP) guidelines; agreements with BC Hydro to supply electricity for LNGC Project in particular the electrification of Phase 2 plant; recommendations on implementation of UNDRIP across ministries; engagement around adequacy of consultation; LNG benefits agreements signed with First Nations in relation to LNG Canada; and workforce development.
- 40. The Manufacturers Life Insurance Company is lobbying public office holders at several public agencies regarding policy recommendations to enhance healthcare and health outcomes in British Columbia, including continued access to health supports through workplace benefits plans.
- 41. UCI Union Cooperative is lobbying public office holders at several public agencies regarding a variety of matters including community economic development; cooperative development; labour policy; funding and support for a centre for community; and worker ownership.
- 42. WSP Canada Inc., is lobbying public office holders at Infrastructure BC Inc. regarding upcoming public projects and market sectors, and recommendations on market perception to procurement models.
